FOR MR ROSCOE STEPHENSON'S FIREARMS INTERNATIONAL VISITOR PERMIT APPLICATIONS

Dear Sir/Madam,

Mr Roscoe Stephenson of 111 Mountaineer Dr., #17, Covington, VA 24426, of the USA will be hunting and shooting with me on my properties in the Barossa Valley in August 2018.

My properties (managed and operated) consist of 307 acres (approx. 124 ha), owned by my father and my father and uncle who are retired. Consisting of vineyards, cropping and grazing properties. In addition I have access to properties of up to 14 square kilometres of grazing properties/bush through permission from neighbours. My principal property – home block – is located at 395 Stockwell Road, Light Pass, South Australia (Section 180 Hundred of Morooroo). The other family properties and neighbours properties are located nearby.

I understand Mr Stephenson will be bringing a double rifle and ammunition for the purposes of shooting targets on my properties and some hunting. And wishes to obtain a Firearms International Visitors Permit to enable the use, import and later re-export of the firearm during his visit to Australia.

I understand Mr Stephenson will also be attending a Big Game Rifle Club of Victoria competitive target shoot in Victoria prior to coming to South Australia, and has arranged documentation from the club for this purpose.


Mr Stephenson and his wife will also be accompanying me on a tourist trip to Northern South Australia, and then Central and Northern Northern Territory to tourist locations. This is a private trip.

I also have arranged a visit to an NT cattle station where we will be shooting/culling feral species such as feral pigs, donkeys and possibly stray scrub bulls on Yeltu Park Station, owned or managed by Ms Penny Tilley in the Katherine Region of the NT. Yeltu Park Station I believe is 230 square kilometres in total size. I have previously shot on Yeltu Park Station and have arranged this shoot for myself plus guest.

Mr Stephenson can store his firearm in a locked case in my second gun safe during his visit with me. Later when travelling any firearms will be secured in the vehicle out of sight, in a secure location, either locked in a lockable drawer or a locked case secured to the vehicle, when not in use. Ammunition will also be stored in a locked box separately.
